DECLARATION OF CONFORMITY TO EC REGULATION 1907/2006, REGISTRATION, EVALUATION, AUTHORISATION AND RESTRICTIONS OF CHEMICALS (REACH)

JSP Ltd confirms that Articles of Personal Protective Equipment (PPE) supplied are compliant with Regulation EC No. 1907/2006 Registration Evaluation Authorisation and Restriction of Chemical (REACH) that came into effect on 1st June 2007 and its subsequent amendments including the recast version.

Substances included within Annex XIV are substances that subject to authorisation from the European Chemical Agency before being placed on the market. JSP Ltd confirm the articles of PPE we supply do not contain substances listed within Annex XIV of the REACH Regulation.

Substances include within Annex XVII are substances that are restricted and may not be placed on the market in mixtures, articles or on their own should they meet the restriction requirements detailed within Annex XVII. JSP Ltd confirm that articles of PPE supplied do not contain substances listed in Annex XVII.

Article 57 of the REACH Regulation outlines the criteria for which a substance can be considered a Substance of Very High Concern (SVHC) based on that substance being carcinogenic, mutagenic or toxic to reproduction. Substances that are persistent, bio accumulative and toxic or very persistent and very bio accumulative are also considered as SVHCs and are also outlined in Article 57. The most recent candidate list of SVHCs can be found on the European Chemical Agency's website (<https://echa.europa.eu/candidate-list-table>) and this list is deemed to be the authentic version by JSP Ltd.

JSP Ltd also confirm that articles of PPE supplied are free from any substances that are on the latest candidate list of Substances of Very High Concern (SVHC) in concentrations greater than 0.1% by weight of SVHC by weight of the product.

JSP Ltd frequently contact our upstream suppliers to ensure that with subsequent updates of the SVHC list to ensure that products we supply continue to remain SVHC free within the concentration limits set in forth in article 7 of EC Regulation 1907/2006.
